3. Legal compliance & risk mitigation

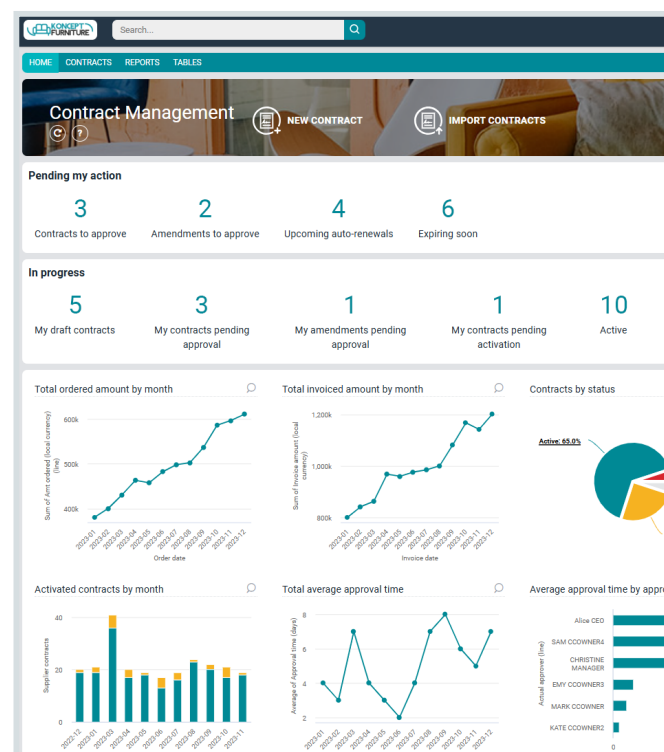
Tracked approval statuses, complete audit trails and integrated e-signatures reduce legal and operational risks.
